Date of issue of postal ballot papers to outstation ARRW members	: 30 th October 2021
Last date of receipt of postal ballots	: 30 th November 2021 (2.00 pm)
Date of Election (at ARRW Head Quarter, NRRI, Cuttack)	: 30 th November 2021 (10.00 am - 2.00 pm)
Counting of Votes	: 30 th November 2021 (3.00 pm - 4.30 pm)

Nominations duly filled in the enclosed form (in original), may please be sent to the Returning Officer latest by **22nd October 2021 (up to 4.30pm)**. Further, withdrawal of nomination will not be considered if it is conditional and a candidate can contest for only one post after final withdrawal.

As per the Clause-9.15 of the ARRW Constitution all Patrons, Life Members and Annual Members (who have paid their annual subscriptions by 31st July for the concerned year i.e. July, 2021 and have been members of the Association for a minimum period of one year prior to the year of election) are eligible to vote, nominate and be able to contest the election.

South: Andhra Pradesh, Karnataka, Tamil Nadu, Kerala, Puducherry, and Andaman & Nicobar Islands.

West: Rajasthan, Madhya Pradesh, Maharashtra, Goa, Daman & Diu and Gujarat
