## Award of Fellowship Association of Rice Research Workers Cuttack, Odisha

- 1. The Association of Rice Research Workers (ARRW), Cuttack, Odisha has instituted a Fellowship to recognize the contributions of scientists in rice science. The Fellowship will be given annually to the scientists who have contributed significantly in improving productivity, profitability and resilience of rice and rice-based systems.
- 2. The objectives of the instituting the Fellowship are to recognize and felicitate the scientists for their significant contributions in improving productivity, profitability and resilience of rice and rice-based systems; involve reputed scientists to harness their knowledge and expertise in accomplishing the goals of the ARRW and outreach and promote the cause and objectives of the ARRW.
- 3. The Nominee should be a distinguished scientist. His/her contribution should have been recognized nationally and internationally and supported by significant publications and technology generations with high impacts.
- 4. The Fellowship will consist of a citation and medal.
- 5. The Fellowship of the Association will be abbreviated as FRA.
- 6. A maximum 5 Fellows will be inducted every year, one each in the following sections: (1) Crop Improvement, (2) Crop Production, (3) Crop Protection, (4) Basic Sciences (Crop Physiology/Biochemistry/Biotechnology) and (5) Social Sciences.
- 7. Fellows will be selected on the basis of their contributions in the field of Rice Research by a Judging Committee (JC) constituted by the Executive Committee (EC).
- 8. The Judging Committee will consist of 7 members: (1) Chairman; (2) five expert members, one each from the five sections mentioned above and (3) Member Secretary. The JC and EC Members will not be candidate for the Fellowship.
- 9. The evaluation of nominations will be based on the criteria described in Annexure I.
- 10. The nominations for the award may be sent in the prescribed proforma (Annexure I), which can be downloaded from the ARRW website www.arrworyza.com. Duly filled proforma should be sent to the Association of Rice Research Workers (ARRW), National Rice Research Institute, Cuttack 753 006, Odisha (Email: <u>secretaryarrw@gmail.com</u>).

Please ensure the following for the nomination:

- 1. Carefully read the Guidelines for Evaluation of Nominations before filling up the Nomination Form.
- 2. Nominations can be proposed and seconded by the head of the academic organizations and Members/Fellow of the ARRW.
- 3. Nomination Form should be signed by both the Proposer and the Seconder.
- 4. A Proposer can nominate maximum two persons and the Seconder maximum three persons in a year. Proposer and Seconder ensure about the integrity of the nominee.
- 5. Proofs for claims made in different items of scientific achievements should be attached.
- 6. Consult the catalogue of journals with NAAS scores and list only those publications that have been published in reputed journals.
- 7. Attach the copies of 20 best publications.
- 8. Cut-off date for receipt of Nominations is **November 30** each year. No additional information furnished by the nominees after the cut-off date shall be considered.
- 9. Proforma with incomplete information will be rejected.
- 10. In case the nominee is not a member of the ARRW, he/she should enroll himself/herself as a life member by depositing a fee of Rs. 6000/- on selection of a Fellow.

### 1. Products and Technologies

### (Max. 38 marks)

- **Products:** Including variety, unique germplasm, genetic stock, chemical and biochemical formulation, diagnostics, vaccines, drug formulation, feed formulation, models of institutional innovations, programming, simulation or statistical models and computer software, including extension software such as expert systems and interactive multimedia, new pest and pathogen identified, new machines/equipment or major modifications in them and development of new value-added products that have been economically evaluated and adopted or have the potential to be adopted on a wide scale. In the case of social sciences, it may include special reports, policy papers, etc. with evidences of influence on research priorities, economic policies and programmes.
- **Technologies:** Research findings that become sustainable practices among the stakeholders. These include integrated pest management, integrated resource management, integrated farming system models, water harvesting and conservation methods, post-harvest technologies, institutional innovations, improvement and innovative extension efforts leading to large-scale diffusion and adoption of technologies.
- The nominees should submit the list of maximum **10 best** products and technologies.
- Scoring: Developer (one) shall be awarded 100% marks, Co-developers 50% marks.

### 2. Publications

### (Max. 28 marks)

### (4 marks for ORYZA)

- (i) Research publications related to rice and rice-based systems only will be considered.
- (ii) The nominees should submit the list of **20 best** research publications any reputed journal and **2 best** research publication in ORYZA journal.
- (iii) Publications will be given marks according to the National Academy of Agricultural Sciences (NAAS) score of Journals (website: www.naasindia.org). Each publication will be given a maximum of 3.0 marks. i.e., a publication in a journal of NAAS score 10 will get 2.0 mark (Mark = NAAS Score/10\*2). A publication in a journal of NAAS score 15 or

above will get 3 marks.

- (iv) First author and corresponding author will get 100%, rest of the authors 50% marks in a publication.
- (v) Attach one set of reprints of the 20 most important publications listed in the nomination, and also submit soft copies of their PDF along with the soft copy of the complete Nomination Form by email.
- (vi) Two publications from ORYZA journal will be considered. Each research paper will get 2 marks. First author and corresponding author will get 100%, rest of the authors 50% marks in a publication.

### 3. Citations

Impacts of the publications will be decided based in the h-index of the scientist. Scientist with hindex >20, 16-20, 10-15 and 5-10 will get 10, 8, 6 and 4 mark, respectively. The snapshot of the Google Scholar h-index and citations should be attached.

### 4. Awards and Recognitions

Each award of International, National, State and Institute levels from reputed organizations will score 5, 3, 2 and 1 marks, respectively. In case of joint awards, the leader shall be awarded 100% marks and associates 50% marks.

### 5. Books and Technical Bulletins

Books/Bulletins (more than 100 pages) with copyright/ISBN No., published by a reputed publisher or organizations. Each authored book scores 2 marks and edited book scores 1 mark. Research bulletin/technical bulletin more than 20 pages will get 0.5 marks and book chapter will get 0.25 marks for each. First/corresponding author will get 100%, rest others get 50% marks.
